LIFE AND TOTAL & PERMANENT DISABILITY [L&TPD] COVER

- L&TPD cover is offered to all members who are eligible* including full time, part time or even casual workers.
- Covers you with automatic default cover of two units [\$300,000] of L&TPD if you are under 40 years of age. Cover can be doubled to \$600,000 without underwriting where policy conditions are met.
- Cost of cover is \$2.37 per week per unit of L&TPD cover [\$150,000 for members under age of 40].

INCOME PROTECTION COVER

- You will also receive income protection cover without the need for medical evidence.
- Covers you for up to 90% of your income.
- Flexible waiting periods of 21 [default], 30, 45 or 90 days are available to reduce premiums.
- Cost of cover for a maximum two year benefit [52 weeks for Mental Conditions] for all types of workers range from: 0.377% of the member's income with a 90 day waiting period to 0.615% for a 21 day waiting period. This is regardless of your age, gender, occupation or how many hours you work.
- As an added bonus, for holding continuous cover for two years or more without making a claim, the benefit payment start date will be backdated to commence up to 21 days earlier. [Maximum benefit period two years].
